6. Chair

- a. Institute Finances we don't have access to the money we know we do have in our BASS account, but we hope to have access starting next year. We can ask our PIC chair more about this later in the meeting
- b. Summer School leadership progression (later this meeting)
- c. Chair Election Committee for Next-Year's Election

7. Secretary-Treasurer

- a. There are minimal updates from ASEE on what money the division has available. Assumption is that once BASS accounts are repaid, we will have ~\$7500 available.
- b. Right now, we can only spend money based on what we've brought in. Unfortunately, these are limited to sponsorships as we are not yet able to access dues.
 - Fernando has a few notes about sponsorship during his report
- c. In the past year, our only expenditures are related to the awards. We anticipate a small cash generation from banquet, but otherwise no real changes to account.
- d. Additional information was provided by Christi Luks:
 - We have just shy of \$10,000 in our account as of right now which is less than the \$12,880 from 9/30/22 which was our last officially provided update.
 - We are going to be repaid that money. They still have about \$5000 in external debt in September and they now have worked out a plan and are paying off external creditors. We still owe 1.3 million to external creditors. We are on track to pay off in January. In February, internal creditors (BASS) will be paid off.
 - In addition paying off old debt we have not accrued any new debt. We are actually in pretty good shape compared to where we were in October.
 - We do need divisions to keep track of how much money you believe we owe you. In February, it's not going to be everyone gets the same 1% each month or something like that. Groups that need access to funds earlier will get that money earlier. We need treasurers to give view of when we need to spend your money.
 - Starting October 1, any dues will be immediately available into new BASS account and be immediately available.
- e. Matt question How did this happen? Christi a few people at corporate were spending money they shouldn't have. They spent things that weren't board approved as they should have. It was broken policy but nothing actual illegal. Future plans to help always will be a member of the board who can see all accounts. The money is no longer siloed as it had previously been. Past silo of information was not
- f. Matt all expenditures were legitimate then? Answer: Yes, and we can expect new safety rails on financial situations
- g. Clarification asked They are spending money they don't have. Were those all non-reoccurring expenses? Christi Nemo is new monolith because we got rid of Slayte. Slayte was purchased without having full membership or board fully analyze if that was a good purchase, as an example.

9. PIC Chair – Elliot (University of Florida)

- a. ASEE has 50+ Divisions that are organized into 5 Professional Interest Councils. We are PIC 1
- b. I'm the liaison between division and board of directors and ASEE staff. How can I help you be successful as a division?
- c. Record setting conference ~4000 attendees with record number of abstracts, 3240 1927 finalized papers
- d. Hope everyone is coming Portland next year to continue!
- e. Working on consistent paper schedule which we wanted to start this year, but we were working through NEMO issues. IT is working on stabilizing NEMO for next year. We set a schedule that we intend to keep each year from here forward.
 - That will be coming out, but did not have the dates with him now.

- f. This year, collecting nominations for ASEE Hall of Fame (in Wednesday Widget email). This hasn't been done since the 100th anniversary, 30 years ago. Please look at how to nominate someone. Difference between Fellow and Hall of Fame: Fellow has service to ASEE as an aspect but Hall of Fame is not but is for people deserving of recognition.
- g. Best PIC 1 paper from LEES, Best overall paper from PIC 2 (Univ of Florida, Faculty Development Meeting).
- h. Big thing this year is finances On Sept 30 it was discovered that operating account and rainy day fund accounts were essentially empty. Thanks to a donation, a forensic auditor went through what happened. All expenses were appropriate for ASEE but result of not very careful financial practices and not completely appropriate spending. Software purchases were put in operating costs instead of capital gains.
 - BASS accounts had been comingled with operating accounts and they are empty but will be paid back
 - Starting this October 1, expected membership incomes and fundraising done this year is available
- i. Questions from Membership:
- Matt having only an hour for lunch is too short and too difficult. Even an hour and a half is really difficult. Lots of places ran out of food yesterday. Jimmy Johns ran out of bread another place ran out of meet. Chipotle had only rice!
- Jennifer Cole Things like multi-division stuff are great, but could we non-compete division things with those interdivisional events. Elliot when there are divisions with similar missions/topics could they not be overlapped so much? We'll look at what we can do as divisions are making decisions, but can we make inter-divisional operations. There are requests to do earlier cooperation meetings between division program chairs to make that easier
- Janie program chairs are scheduling simultaneously so it's really hard to know what other divisions are doing. Elliott Maybe the new timeline and system will make this easier. David Suggestion 2nd round of scheduling to be able to move things around would maybe be a way to help with that?
- David we've never had enough chairs for business meeting. Joe noted that at ticketed Fellows lunch they didn't have enough chairs and they knew how many would come!
