Agenda

- 1. PIC 1 Chair Update (Eliot Douglas)
 - a. There are 5 PIC chairs which each has 10-12 divisions that we help. We sit on board of directors and are the liaison to the board. He has 1 more year on his term
 - b. ASEE working on new strategic plan Stakeholder input on draft priorities open now for 1 more week.
 - Redefine ASEE's Value Proposition and Continuously improve members experience
 - Increase membership for a thriving community of practice
 - Financial sustainability (top of pyramid)
 - c. Status of finances.
 - Operational costs reduced (58 employees down to 34) other operational costs reduced like renegotiating HQ rent and eliminating some long-term document storage
 - \$10M in grants so increase in revenue
 - Audits of prior year finances ongoing (FY18 and 19 complete, FY 20 in progress, expect to be caught up by end of FY 25)
 - As financial audits are completed, overhead rate for that year is finalized. Final rates are likely lower than provisional rates, requiring payback to the government as audits are completed.
 - Future committees identified changes to constitution, bylaws, and financial policies (many changes expected)
 - d. BASS Accounts
 - BASS accounts are not frozen, the were emptied prior to October 1, 2022
 - Timing of repayments to BASS accounts is uncertain
 - 1. Need to wait at least until financial audits are complete and government paid back.
 - 2. Total owed to BASS accounts is over \$1M
 - Division dues collected as of October 1, 2023, are being added to BASS balances
 - Division allocation of \$1 per member will be added to BASS balances in October -
 - reallocation that hasn't been done in the past. Based on membership as of March 31st.
 - e. Membership
 - 2004 was height but have dropped to ~8800 members and seems fairly stable over last 4 years.
 - Want to look at membership and improve retention. We get 200 new members a month but are also losing members at about the same rate. Why aren't they renewing?
 - f. PIC/Conference Updates
 - NEMO pretty good but limited possibility for upgrades
 - Divisions can fundraise to support activities
 - COI policy papers submitted by program chairs are handled by the PIC Chair
 - g. Distinguished Lecture title returned
 - Every division can have one Distinguished Lecture
 - 2024 conference has 7 Distinguished Lectures
 - New this year: PIC sessions

- h. Paper Deadlines for 2025 about 1 month to 3 weeks earlier than last year (helps cash flow)
 - Abstracts open September 1
 - Abstracts due October 1
 - Abstract decisions November 1
 - Draft papers due January 15
 - Draft decisions February 7
 - Revised papers due February 21
 - Revised paper acceptance due March 7

 - Best conference came from PIC IV First Year Programs
- k. Sarah question came up about documentation of IRB within submitted papers. Lots of our papers didn't mention it but is there a way to ask about it at the ASEE level? Elliot we now have VP of Scholarship and looking at this vs. PIC? That is with Scholarly publications committee to consider. There is some discussion happening if it should be and how it should be considered. Sarah noted that it is not consistently reviewed.
- Reg In regards to communication between leadership. We had the new position of the BASS account, and we weren't getting BASS account information to only the BASS accountant holder only. Elliot in the future, make the BASS account holder the treasurer. David in the beginning it seemed that this was a position in order to add other check and balance and not that it was just two positions to the same person.
- m. BASS account statements only started going out in January or February of this year.

 - In the past, we've been told that payback is going to be prioritized for divisions that have immediate need so we were not provided an exact timeline.
 - c. The Fundraising Committee has been able to find good revenue for support of division awards. This has been our only expenses in the last few years.
 - d. As of March 2024, we have an available balance of \$5,835 and an unavailable balance of \$11,124.
